


2010 ANNUAL REPORT









from the **COLLEGE PRESIDENT**

The past year has been an exciting one for South Arkansas Community College. We had record enrollments in both credit and non-credit courses, and a record number of students graduated.

The respiratory therapy program accepted its first class of students, and the surgical technology program achieved initial accreditation.



The college received two federally-funded grants totaling more than \$5 million: appropriations from the Health Resources and Services Administration for the health-science building and funds from American Recovery and Reinvestment Act to reroof two buildings and assist with energy efficiency.

We held groundbreaking ceremonies for the Health Science Center and for the El Dorado Conference Center (which also will house our student center, bookstore and cafe).

Nearly 50 scholarships were awarded through the Foundation to deserving students, enabling them to seek and complete their education and prepare for the workforce.

Thanks to the ongoing interest, support and generosity of donors like you, the SouthArk Foundation is able to provide continued support for the students of SouthArk and for college building projects, programs and initiatives.

The college's mission is to promote excellence in learning, teaching and service; provide lifelong educational opportunities; and serve as a cultural, intellectual and economic resource for the community. With the mission as our guide, faculty, staff, trustees and community members developed a strategic plan for SouthArk: Build 2016. The plan provides us with goals to assure that higher education is accessible, students are successful, partnerships are meaningful, and resources are available to provide for the educational needs of

our community.

We take great pride in preparing a quality workforce, whether nurses and health-care workers, welders, administrative assistants, computer technicians, teachers, or automotive specialists; or those transferring to area universities. SouthArk is in the business of educating individuals in the community.

The annual report provides highlights of the activities of the Foundation and the college. It recognizes the many contributions of our volunteers, supporters, and philanthropists. It tells the story of the students that benefit from your generous support. With limited state appropriations, it is only through donations to our programs, projects, and students that SouthArk is able to successfully move forward.

The Foundation is an integral part of and a major contributor to the future progress and success of the college. Our vision is to be the leading resource for accessible education, workforce training, partnerships and economic development for our region. We hope that you will make our vision yours, as we make plans for the coming years at SouthArk.



COMPETITIVE HEALTHCARE GRANT

TOTALS \$3.5 MILLION

In February 2010, SouthArk learned that it would receive a grant in the amount of \$3.5 million through the American Recovery and Reinvestment Act of 2009 from the U.S. Department of Labor.

The college applied for the grant in the fall. Only one other institution in Arkansas and 55 nationwide received such a grant among the more than 1,400 applicants.

The grant sets healthcare as its target and will be used in part to fund additional instructors, equipment in the new Health Science Center and new programs such as medical laboratory technology.

Partners in the effort include the Medical Center of South Arkansas in El Dorado, Ashley County Medical Center in Crossett, Magnolia Hospital and Ouachita County Medical Center in Camden, among others.

The goal is to strengthen and broaden SouthArk's ability to educate and train new medical personnel in and around south Arkansas, a move designed to benefit the entire region, according to Dr. George Roberts, Dean of the Health and Natural Sciences Department.

"Receipt of the South Arkansas Healthcare Opportunities grant...will greatly benefit South Arkansas Community College and south Arkansas," Roberts said.



MAJOR GIFT HELPS MAKE MAJOR DIFFERENCE


The building's primary lecture hall will be named in honor of the bank, according to Dr. George Roberts, division dean of Health and Natural Sciences at SouthArk. Roberts said that First Financial's donation is much appreciated and that because of continued explosion in enrollment, SouthArk is in need of the classroom space that the new building will provide. About 45 percent of SouthArk's students are on a health-science educational track, he said.

"Right now we're bursting at the seams to find classroom and lab space," Roberts said. The lecture hall will also provide additional space for community professional development programs that SouthArk is developing."

A CORNERSTONE OF THE FOUNDATION

"From her role in the stark conditions of the early days of SouthArk, with a job description that read 'whatever needs to be done' to her long list of academic and professional credentials, I see a foundation carefully laid

that would support a life and career committed to serving this college and its students," former Foundation board chair John Dews said of Dr. Langston.

Seeing from the beginning the college's vast potential for helping the people of south Arkansas, she invested not only her time and expertise in growing the fledging school but also her financial resources. Dr. Langston's financial philanthropy has led to the creation of two different fully-endowed scholarships for student learning. These named scholarships are the Langston Endowed Scholarship and the Mabel Stratton Powell Endowed



Scholarship, the latter having been established in memory of Dr. Langston's mother, a lifelong supporter of teaching and learning and inspiration for those seeking to further their education. These scholarships reflect her abiding belief in the power of education to transform lives and to grow communities and her willingness to invest personally and joyfully in this worthwhile enterprise.

With the addition of the Health Science Center and the city-financed El Dorado Conference and SouthArk Student Center and with a generous \$5 million gift from Murphy Oil Corporation, the SouthArk West Campus is beginning to have the look and feel of a college campus.

Record enrollment made building a parking lot adjacent to the Health Science Center necessary. With the additional 230 parking spaces and the purchase of adjacent properties, the campus master plan of adding green space in the central West Campus area has become plausible.

Discussions have suggested a two-stage approach. The first would include a central plaza, a tree-lined walkway from the Administration building to the Library and a brick-paved walkway between the Computer Technology Building and the Health Science Center.

It is hoped that this area will provide gathering and outdoor learning spaces for students, faculty, staff and community members. It is envisioned that the plaza will recognize the historical educational heritage of the campus and the legacy of learning that it represents.

The campus transformation also will include a renovation of the landscaping in front of the Whitfield Building so that it will mirror that of the new conference center.

The second stage of this plan will be to complete the quadrangle green space, once additional parking areas are developed.






Asset Growth History


