- B. Personnel/Planning Committee Mr. Gary Griffis, committee chair, presented a recommendation from the committee to increase President Jones' annual salary by \$6,000, or 3%, to a fiscal year amount of \$192,292 and retroactive to July 1, 2016. Board approved.
- C. Budget/Finance Committee Mr. Steve Cameron, committee chair, noted that the Facilities and Finance Committees held a joint meeting on September 7th. He presented a recommendation from the committees for SouthArk to enter into a performance contract with Johnson Controls and financing through Bank of America, pending Arkansas Higher Education Coordinating Board approval for the economic feasibility of SouthArk to finance the project. The cost of the project will be approximately \$2.5M and financed through a conventional loan at no more than 2.05% interest. Mr. Cousins recused himself from the vote. Board approved.

A. August Monthly Statements

August 2016 highlights included total unrestricted revenue of \$3,608,681, which is 25.55% of the total budget of \$14,121,336. Total unrestricted expenses of \$2,060,622 which is 14.59% of the total budget of \$14,121,336. Total revenues over expenditures at August 31, 2016 were \$1,548,059. Total cash and investments at August 31, 2016 were \$6,772,786.

A. Administrative Reports

Vice President for Finance and Administration – Mr. Carey Tucker

Conference Center

1. Mr. Reynolds Boykin continues to serve as interim chef for Valley Services, while the search for a chef is ongoing. To help support and celebrate SouthArk's International Week, Mr. Boykin has a great menu of international cuisine for the Bistro this week.

Financial Reporting

1. The majority of annual reporting was completed September 16.

Human Resources

1. Bill Fowler was hired as the new Human Resources (HR) Director and began working September 13, 2016.

Physical Plant

- 1. The Heritage Plaza fountain has been out of commission for almost a month. The college contracted with Glenn Mechanical to install a relief valve. One more part is needed and has been ordered to complete the work to make the fountain operational.
- 2. SouthArk is working with CADM Architecture to finalize plans for the AMTC.

Vice President for Learning – Dr. Mickey Best

Career & Technical Education:

1. Secondary Technical Center enrollment is up 46% over last year.

Distance Learning:

- 1. The Distance Learning Department took part in the Closing the Distance Seminar Series, which is an online joint faculty training collaboration between South Arkansas Community College, Southern Arkansas University, and Southern Arkansas University Tech on September 1st.
- 2. In cooperation with the Dean of Career and Technical Education and a welding instructor, a course in Industrial Fundamentals is being developed and is expected to be approved as a new distance education course and will be offered as an 80% online (hybrid course) in the spring of 2017.

Health & Natural Sciences:

- 1. Nursing: All USDA grant equipment for SouthArk has been received and is under installation, including SimMom (Labor and Delivery simulator mannequin), the Omnicell (medication delivery machine), and the SimView video system.
- 2. OTA received notice of full re-accreditation for 7 years.

Library: Phillip Shackelford

- 1. Prior to New Student Orientation the library launched on 3 social media platforms: Facebook, Instagram, and Twitter. Since that time the library has reached over 1400 people via Facebook and over 900 of those have engaged with Facebook posts, as well as interactions via Twitter and Instagram.
- 2. Saturday, September 24th, is the 20th Anniversary of the SouthArk Library's dedication. The week of September 19-23 has been set aside to celebrate this milestone, and planned events include a book sale, "College Day," and a commemoration reception on Wednesday, September 21st.

Vice President for Student Services – Dr. Jim Bullock

Student Services Division

1. **Higher Learning Commission (HLC).** An examination draft of the HLC Assurance Argument was completed in August and shared with the review team at ASU-Newport that will be conducting a "mock visit" on September 26-27. Also, a draft of the Federal Compliance Report and the final draft of our Quality Initiative on critical thinking were completed.

The review drafts of the Assurance Argument and the Federal Compliance Report as well as the submitted draft of the Quality Initiative have been shared with the campus community, inviting additional input in the way of corrections and suggestions. After the mock visit team offers its report following their visit on September 26-27, the administration will have a last opportunity for revision before submitting the final documents to HLC by October 15.

2. National Emergency Grant/Arkansas Sector Partnership (NEG/ASP)

o In the month of August, the NEG career counselor shared grant information with 18 new individuals through the WAGE program and the mandatory workshop on unemployment benefits for those on parole/probation. Two grant participants have completed the WAGE program, and one participant achieved success by graduating from the "Fast Lane" program/course during the summer with a certificate of proficiency in industrial technology. This student continues at SouthArk working toward her technical certificate.

Enterprise Resource Planning (ERP) upgrade

The Jenzabar project is ongoing. SouthArk staff continue to refine their business practices and to familiarize themselves with Jenzabar EX.

UAMS e-Link Consortium

Arkansas Research and Education Optical Network (ARE-ON) has received the consortium's funding letter from the Universal Service Administrative Company (USAC) for fiscal year 2015-16. The money will be disbursed to ARE-ON and it will reimburse the consortium institutions (65% of our annual ARE-ON membership fee – annual savings of \$15,000). They are submitting our application for this fiscal year, and anticipate that funding in January.
